Revision

Your steps and deadlines:

- ❖ Come to Russia with valid documents, obtain a migration card underline “Education” as your travel purpose
- ❖ Get registered at your place of living in **7 working days** after arrival
- ❖ Extend your visa in **45 days** before its expiration
- ❖ Extend your registration in **3 working days** after getting a new visa
- ❖ If you travel, get registered at places of stay and re-registered within **2 days** after you return
- ❖ Use **ivisa.hse.ru** for guidance
