
**On Introduction of Amendments to Directive of the Ministry of Health of the Russian Federation No. 198H, dated March 19, 2020
“On Temporary Procedures for Organizing the Operations of Medical Care Facilities for the Purpose of Implementing Measures to Prevent and Contain the Spread of the Novel Coronavirus Infection Covid-19”**

In line with Federal Law No. 323-FZ “On the Framework for Protecting the Health of Citizens of the Russian Federation”, dated November 21, 2011 (Legislative Bulletin of the Russian Federation, 2011, Issue 48, Art. 6724; 2020, Issue 31, Art. 5062) and pp. 5.2.208 of the Regulations on the Ministry of Health of the Russian Federation, approved as per Resolution of the Government of the Russian Federation No. 608, dated June 19, 2012 (Legislative Bulletin of the Russian Federation, 2012, Issue 26, Art. 3526), I hereby order to:
