



If you cross the border through Belarus, make sure to specifically ask for this document as it's not issued for Belarus citizens

Check the spelling of your name and its translation, you will need to use the ID you show at the border during all other procedures in Russia. All data must fully correspond!












Do not fail to get registered within the first days after arrival, otherwise you will be subject to a state penalty and deportation!

### **OBLIGATORY PROCEDURES - WHO SHOULD PASS THEM** AND WHEN?

#### Federal Law of 1st of July 2021 No 274:

ФЕДЕРАЛЬНЫЙ ЗАКОН Federal Law of 1st of July 2021 NO 217. All foreign citizens who arrived in Russia after 29.12.202, and intending to stay here over 90 days <sup>«O правовом положений в Федеральный закон</sup> All foreign citizens who arrived in Russia and 23.12.202, and mentions of the arrival date of the arrival date of the obligatory procedures within 90 days from the arrival date of the ar алоскопической регистрации в Российской Федерации»

РОССИЙСКАЯ ФЕДЕРАЦИЯ

All foreign citizens who arrived in Russia before 29.12.2021, nd intending to stay here over 90 days continuously, must undergo the obligatory procedures until 29.12.2022

- **Medical Examination** 1.
- **Fingerprinting and photographing** 2.

#### Exempt from procedures:

- Citizens of the Republic of Belarus;  $\star$
- Family members of international officials and employees of diplomatic and consular institutions  $\star$ in Russia:
- Foreign nationals with dual citizenship, one of which is Russian;  $\star$
- $\star$ Foreign nationals – holders of temporary or permanent Russian residence permits.



If you fail to undergo the obligatory procedures in time you are subject to cancellation of your visa and registration, deportation from Russia and rejection of further entry for 5 years!

## Where and how to pass the obligatory procedures?

### HSE offers assistance: for payment Undergo Medical examination, Fingerprinting and photographing at Sakharovo Migration Centre

Address: Voronovskoye settlement, Varshavskoye schosse, 64y km, vl1 bldg 47. By bus from Metro station Lesoparkovaya Book a place on the bus to Sakharovo here



#### Underage children pass

the Medical examination at <u>Children's polyclinic</u> <u>№38</u> (without parents' consent) Fingerpringing and photographing at MVD/Sakharovo with:

- parents accompanying them
- officially authorized representative with the notarized consent of parents
- alone with the written notarized consent of parents + copies of their documents and birth certificate

#### documents you will need:

- Passport + copy;
- Translation of your passport into Russian verified by the notary + its copy;
- Visa copy;
- Migration card + its copy;
- Registration slip + its copy:
- Money for the state fees



## **VISA EXTENSION**


#### **Apply in person bringing these documents:**

- Passport and copy of all filled pages
- Migration card, registration and their copies
- Documents proving your student status (certificate of studies, enrollment order, study agreement copy/ scholarship document copy) order them at <u>https://studentcentre.hse.ru/</u>
- 1 photo (3x4)
- Receipt of state fee payment (order requisites at <u>visa-registration@hse.ru</u>)

Apply for visa extension in person as early as **90 days and as late as 45 days** prior to your current visa expiration date. Extend your registration in 3 days after getting a new visa.

You will require a fingerprinting certificate

to extend your registration, make sure to get it beforehand!

### What to Do if You Have Lost Your Documents...

If you have lost your migration card  $\odot$ 

If you have lost your registration slip  $_{\bigodot}$ 

If you have lost your passport with a Russian visa

If you have lost your passport (visa-free entry)

You will need an assistance of a Russian speaking buddy - find one here

**Step 1** : Contact the police, report the loss, get the corresponding certificate

**Step 2** : Inform the passport officer of your dorm and <u>Visa</u> and <u>Registration Centre</u> on your loss

**Step 3** : Receive a duplicate of the lost documents in MVD office at the address of your registration (in case you've lost your passport get a new one in the embassy of your country in Moscow)

Step 4 : Send a copy of the duplicate toVisa andRegistration Centreand to the passport officer of your

dorm
